Statement from KartSport New Zealand regarding an Inquiry into Rotax Max Challenge Round 3, KartSport Bay of Plenty, 26-27 March 2011

Further to our notice dated 1-4-11, the Inquiry was held in Auckland on 1-5-11.

The Terms of Reference for the Inquiry were as follows:

To review all aspects related to Form of Complaint's #409828 (B Hart), #409095





(S Grocock), #409829 (G Claxton), #409098 (D Kinsman) and #409099 (L Moore) including the eligibility of the chassis concerned, the respective hearings and decisions of the event Stewards Panel.

- 2. To consider all relevant matters related to Rule K1.(d).
- 3. Having considered Items 1 and 2, determine whether there have been any breaches of KartSport New Zealand Regulations, Codes, Rules and/or Specifications.

The Inquiry Panel was: L Hickey (chair), G Moore and C Richardson.

A full Inquiry Report will be issued later however due to the interest in this matter the following is a summary of the decisions made regarding the chassis concerned:

- The Inquiry determined that in terms of Regulation B6, the spirit and intent of the Rule had
 not been upheld, however it was demonstrated to the Inquiry that the impounded
 chassis presented very slight magnetic properties, therefore were considered technically
 compliant to Rule K1(d).
- All parties to the Inquiry proceedings, including Lascom Motorsport, agreed that, although
 the chassis could be shown to be "magnetic", that a better definition of "magnetic" in Rule
 K1(d) would be desirable for all.
- The results of the event were confirmed as published on the day.

Recently implemented Rule ChangesA reminder regarding some recently implemented rule changes.

- Mobil Pump Petrol is no longer an approved fuel (Rule L4.1)
- Yamaha KT100 Ignition Cover (Rule N1.19)
- The ignition cover must be in situ. Any holes in the ignition cover must be used (eg to
 mount a TCI) and any holes not used must be blanked by means of nut and bolt (with or
 without washer) or rubber grommet. Adhesive tape is not permitted.
- Rotax Max Piston (Rules N12.33 and N14.31) Piston crown contour must conform to KartSport New Zealand Tech gauge. Carbon deposits can be removed before using the gauge.
